

INVITATION TO BID FOR THE PROCUREMENT OF THE SUPPLY, DELIVERY, AND INSTALLATION OF VARIOUS OFFICE FURNITURE FOR THE NATIONAL DEVELOPMENT COMPANY (NDC)

- 1) The **NATIONAL DEVELOPMENT COMPANY (NDC)**, through the **Corporate Operating Budget FY 2025** intends to apply the sum of **Two Million Eight Hundred Fifty-Three Thousand Five Hundred Pesos (₱2,853,500.00)** being the Approved Budget for the Contract (ABC), to payments under the contract for **PROCUREMENT FOR THE SUPPLY, DELIVERY, AND INSTALLATION OF VARIOUS OFFICE FURNITURE FOR THE NATIONAL DEVELOPMENT COMPANY (NDC)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The NDC now invites bids for the *supply, delivery and installation of various office furniture for the National Development Company (NDC)*. Delivery of the Goods is required *sixty (60) calendar days from receipt of Notice to Proceed (NTP) by the winning bidder*. Bidders should have completed, at least *five (5) years* from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR of RA No. 12009.
 - i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4) Interested Bidders may obtain further information from **NDC** and inspect the Bidding Documents at the address given below from **8:00 am to 5:00 pm**.
- 5) A complete set of Bidding Documents may be acquired by interested Bidders on **November 24, 2025**, from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIVE THOUSAND PESOS (₱5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6) The NDC will hold a Pre-Bid Conference on November 28, 2025, Friday, 10:00 am through Zoom video conferencing which shall be open to prospective Bidders.

- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
- 9) Bid opening shall be on December 10, 2025, 11:00 am at ABB Hall Penthouse, NDC Building, 116 Tordesillas Street, Salcedo Village, Makati City. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
